SUBJECT: Appointments for Montecito Planning Commission & Board of Architectural Review

Recommendation(s):

That the Board of Supervisors approve the following appointments to the Montecito Planning Commission and Board of Architectural Review:

Montecito Planning Commission:

I recommend for appointment to the Montecito Planning Commission: Bob Bierig, Michael Phillips, and Richard Thielscher for a term of two years terminating at 12:00 Noon on the first Monday after the first day in January 2005; and Bob Meghreblian and Joan Wells for a term of one year terminating at 12:00 Noon on the first Monday after the first day in January 2004. The MPC will commence meeting March 2003.

Montecito Board of Architectural Review:

I recommend for appointment to the Montecito Board of Architectural Review: Ray Ketzal, Sam Maphis, Michele Michaelson, Anthony Spann and Hubert Twibell for a term of four years terminating at 12:00 Noon on the first Monday after the first day in January 2007; and Claire Gottsdanker and Donald Nulty for a term of two years terminating at 12:00 Noon on the first Monday after the first day in January 2005. The MBAR will commence meeting March 2003.

Alignment with Board Strategic Plan:

The recommendations are primarily aligned with Goal no. 1: An efficient Government Able to Respond Effectively to the Needs of the Community, and Goal No. 6: A County Government that is Accessible, Open and Citizen Friendly, and is required by law or routine business necessity.

Executive Summary and Discussion:

On June 4 and June 18, 2002 the Board approved ordinance amendments to form the Montecito Area Planning Commission and Board of Architectural Review, and directed staff to return to the Board prior to Fiscal Year 04-05 with a status report and fiscal analysis on the Montecito Planning Commission (MPC) and Montecito Board of Architectural Review (MBAR). These appointments will seat the first MPC and MBAR members.
