First Amendment

This is a first amendment (hereafter referred to as the First Amended Agreement) to the Agreement for Services of Independent Contractor, number BC#16-062 (the "Agreement") by and between the **County of Santa Barbara** (COUNTY) and **All Ways Clean** (CONTRACTOR), for the continued provision of Janitorial services.

RECITALS

Whereas, the parties desire to amend the Agreement to increase the amount of services and compensation in the existing Agreement; and

Whereas, this First Amended Agreement incorporates the terms and conditions set forth in the original Agreement, approved by the County Board of Supervisors on June 23, 2015; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, COUNTY and CONTRACTOR agree as follows.

The Agreement is amended as follows:

1. Section A of Exhibit B is amended to state in its entirety:
 - A. For Contractor services to be rendered under this Agreement, Contractor shall be paid a total contract amount, including cost reimbursements, not to exceed \$121,380.00, for the period of July 1, 2015 through June 30, 2016, invoice monthly. Annual Cost \$121,380.00.
2. Attachment A-1 is replaced in its entirety, with *Attachment A-1, REVISED 9/15/15*, as attached hereto and incorporated herein by reference.

In all other respects, the Agreement remains unchanged and in full effect.
