That the Board of Supervisors:

- A. Approve plans and specifications for Construction of 2006/2007 County Wide Measure 'D' Preventive Maintenance Application of Scrub Seal and Micro Surfacing, County Project No. 820607,
- B. Award the Construction contract in the amount of \$1,427,742.00 to the lowest responsible bidder, Intermountain Slurry Seal, Inc. (Not a Local Vendor), subject to the provisions of documents and certification, as set forth in the plans and specifications applicable to the project and as required by law;
- C. Authorize the chair to execute the construction contract upon return of the Contractor's executed contract documents, and the review and approval of the County Counsel, Auditor-Controller and Risk Manager or their authorized representatives;
- D. Approve a contingency amount of \$83,887.10 for Construction of 2006/2007 County Wide Measure 'D' Preventive Maintenance Application of Scrub Seal and Micro Surfacing, County Project No. 820607.

Summary Text: On Thursday, March 1st, 2007, three (3) bids were opened for the Construction of 2006/2007 County Wide Measure 'D' Preventive Maintenance Application of Scrub Seal and Micro Surfacing, County

Project No. 820607. Intermountain Slurry Seal, Inc., a California Corporation, submitted the lowest responsible bid in the amount of \$1,427,742.00, which was 13% below the Engineer's Estimate.

Staff has performed an analysis of the bids received and has determined that the low bid is responsive and responsible. Staff recommends awarding this contract to Intermountain Slurry Seal, Inc.

The Scrub Seal and Micro Surfacing project is one of the strategies the Department employs in its annual Pavement Preservation Program. The Scrub Seal is a process by which a polymer modified asphaltic emulsion with rejuvenating agent is applied to the existing pavement surface. A specifically designed drag broom is then pulled through the emulsion filling the cracks and voids and followed by the placement of various sized aggregate then rolled by pneumatic tire compactors. Micro Surfacing is then placed on top of the scrub seal on most locations 24 hours later. The Micro Surfacing is a mixture of polymer modified asphalt emulsion, mineral aggregate and filler providing a smoother finished surface. Approximately 30 lane miles of County maintained roadway will be resurfaced with the construction of this project. This is a cost effective surface treatment strategy that other local agencies with limited funds have utilized successfully.

This project was bid in accordance with the Public Contract Code, which requires the award to the lowest responsible bidder.
