**NOTICE OF TERMINATION OF AGREEMENT** 

Re: Termination of Agreement for Services of Independent Contractor with Good Samaritan Shelter for Fiscal Years 2021–24 (Board Contract Number 21-031), Effective June 30, 2023

Dear Sylvia Barnard,

On July 18, 2023, the Santa Barbara County Board of Supervisors voted to terminate the abovereferenced agreement with Good Samaritan Shelter ("Good Sam") (the "Agreement") for convenience, effective June 30, 2023, as follows:

Section 19 of the Agreement authorizes termination of the Agreement by the County for convenience. The termination of the Agreement follows Santa Barbara County Department of Behavioral Wellness' ("BWell") award of the Drug Medi-Cal Organized Delivery System ("DMC-ODS") Residential Treatment Programs, Outpatient Treatment Programs, and Recovery Residences Request for Proposals, issued on October 4, 2022, to Good Sam.

As a result of this termination, the maximum contract amount of the Agreement has been reduced and will no longer include the amounts designated for fiscal periods subsequent to June 30, 2023.

Furthermore, as indicated in Exhibit B-ADP, Section VII, Part E (Withholding of Payment for Nonsubmission of Service Data and Other information) and Exhibit B-MHS, Section VI, Part D (Withholding of Payment for Non-submission of Service Data and Other information) of the Agreement, final payment shall be withheld until the County is in receipt of complete and correct data, and this data has been reviewed and approved by the Director of the Department of BWell ("Director") or designee. The Director or designee will review this data within 60 calendar days of receipt. In addition, in accordance with Exhibit B-ADP, Section VIII (Cost Report) and Exhibit B-MHS, Section VII (Cost Report) of the Agreement, we require your agency to submit a Cost Report following the end of the fiscal year.

As described in Section 14 (Records, Audit, and Review) of the Agreement, accounting and business records for the Agreement must be retained by your agency until the State Department of Health Care Services completes its final audit for fiscal years 2022–23. Records relating to prior year agreements are subject to the same terms for those years.
