- New Program Rental Housing Incentive Ordinance
- Update Program 5 Tools & Incentives for High
 Quality Affordable Housing
 - Study options for long-term funding source for affordable housing
- Update Program 10 ADUs
 - Increase expected unit count from 100 to 150

Housing Element Revisions

- Update Program 16 Reduction of Governmental Constraints
 - Amend MGMO to facilitate housing in Montecito needed to meet RHNA

19 New Sites



South County Sites

- 7 new county owned sites
 - 3 at the Calle Real Campus
 - 2 at the Hollister Campus
 - 2 in downtown Santa Barbara
- 2 new sites in Montecito
 - Employee housing Miramar Rosewood Hotel
 - Employee housing -Biltmore Hotel

South County Sites (cont.)

- 1 new site in Isla Vista
 - Friendship Manor property
- 3 UCSB faculty/staff housing projects on campus
 - Ocean Road Project (540 units)
 - Devereux North Knoll (125 units)
 - Ocean Walk (70 units)

South County Sites (cont.)

- 2 sites in Eastern Goleta Valley
 - Montessori School property
 - Tatum property
- 1 new site in Carpinteria
 - Bailard property

North County Sites

- 1 site in Vandenberg Village
 - Apollo Way
- 2 new sites in Orcutt
 - KS11
 - Element Church property
- 1 Adjustment in Orcutt move MRO from KS 3 to KS 1 (no unit increase)

New Sites - Additional Units

- 19 new sites could accommodate 2,151 units:
 - 518 lower income
 - 666 moderate income
 - 967 above moderate income (market)
- Expands range of rezone options for BOS

Future Mixed-Use Units

- Secondary list of commercially zoned properties
- Properties will benefit from:
 - Program 16 Modernization of Commercial zones
 - New State laws AB 2011 and SB 6
- Future housing anticipated on non-vacant commercial sites
- Local list of sites not seeking HCD approval
- If housing is developed, will contribute toward meeting allocation
