Alignment with Board Strategic Plan:

The recommendation(s) are primarily aligned with Goal No. 4. A Community that is Economically Vital and Sustainable.

Executive Summary and Discussion:

The EDAC approved the allocation of the Fulfillment Funds (also known as the Advertising Budget) at their April 8, 2002 meeting. Allocations for each organization are based on the population within their sphere of influence and whether or not there are incorporated cities within that sphere. With the incorporation of the City of Goleta the allocation rate for fulfillment funds for the Goleta Valley Chamber of Commerce changed from \$ 0.80 per capita to \$ 0.50, resulting in a funding reduction of \$18,500, from \$49,100 to \$30,600. The City of Goleta will not be providing the Chamber with funding to make up the difference for the FY 2002-03. EDAC voted to fund the Goleta Chamber at \$40,297 for FY 2002-03 as a one-year only transitional measure. EDAC also recommended the addition of the Santa Ynez Valley Visitors Association to the organizations receiving Fulfillment Funds.

The recommendations were incorrectly listed in the Proposed FY 2002-03 Budget the Board approved June 14, 2002. If approved by the Board, this recommendation will allocate the funds as originally recommended by EDAC.
