Approve and authorize the Chair to execute the "Subdivider's Agreement to Construct and Maintain Private Drainage Improvement and Private Drainage & Maintenance Easements" with Cameron Realty Partners, LLC, owners of Orcutt Creek Estates, Tract 14,627 (APN: 103-740-016).

### **Summary Text:**

The Subdivider's Agreement is a condition of approval for Orcutt Creek Estates located on Bradley Road near Clark Avenue in the Orcutt area. The project will divide 9.29 acres into 17 parcels; 16 single family residences and one open space parcel. This agreement will require the present and future owners of the property to be responsible for the maintenance in perpetuity of the project drainage improvements of Tract 14,627 (03DVP-00000-00045).
