- A. Approve the amended Conflict of Interest Code of the Goleta Union School District (Attachment D) and
- B. Determine that the above action is an organizational or administrative activity of the government that will not result in direct or indirect physical changes in the environment and is therefore not a project under the California Environmental Quality Act (CEQA) pursuant to section 15378(b)(5) of the CEQA Guidelines.

Summary Text:

The Governing Board of the Goleta Union School District adopted its Conflict of Interest Code amendments on August 17, 2022. Amendments to the Goleta Union School District's Conflict of Interest Code are required to revise the titles of existing positions and delete the titles of positions that have been abolished and/or positions that no longer make or participate in making government decisions. Background:

The Political Reform Act of 1974 requires every local government agency to:

- 1. Adopt a Conflict of Interest Code identifying the reporting requirements of covered employees;
- 2. Review the need for any changes to its code biennially; and
- 3. Submit an amended code to the "code reviewing body" if necessitated by changed circumstances. (Gov. Code, §§ 87300; 87302; 87306.5, subd. (a).)

The Board of Supervisors is designated as the code reviewing body for independent districts and agencies with jurisdiction wholly within the County. (Gov. Code, § 82011, subd. (b).) Once approved by the Board, Goleta Union School District's amended Conflict of Interest Code is deemed effective. (Gov. Code, § 87303.)
