- 2) Commissioner Valencia moved, seconded by Commissioner Cooney and carried by a vote of 5-0 to recommend that the Board of Supervisors provide direction to prepare a regional planning study of this area of the Highway 246 corridor or for the greater Lompoc, Vandenberg Village and Mission Hills area.
- 3) Commissioner Blough moved, seconded by Commissioner Valencia and carried by a vote of 3-2 (Brown/Cooney no) to defer the decision as to whether or not to initiate the General Plan Amendment to the Board of Supervisors.
