## FY2008-09 Budget Cuts: \$2.6 million

Programs and Services Reduced:

23.37 FTEs Unfunded or Eliminated

- Management and Line level Deputies
- Civilian positions eliminated
- Staffing now equivalent to FY 1999/00 level

Services and Supplies held at prior year levels



#### FY2008-09 Budget Cuts: \$2.6 million

- Cut overtime
- Furlough
- Deferred Pay Increases (DSA and Sheriff's Mgmt.)
- No Leadership Bonuses
- Extra Help for Cost Savings
- Internal Hiring Freeze
- Deferred Purchases (services and supplies)
- Delayed Vehicle Replacement
- Civilianization of Sworn Positions
  - Forensics, PIO



# Sheriff's Department 10% Cut = \$6.2 Million Dollars



#### 10% Cut???

#### \$6.2 Million

- Layoff of 20 Law Enforcement Deputies
- Layoff of 14 Custody Deputies/Closure of Santa Maria Branch Jail
- Reduction of 9 sworn positions in Enforcement and Investigative Units (Narcotic & Gang Suppression, Detectives)
- Reduction of 9 civilian positions
- Elimination of Emergency Medical Dispatch services eliminate 3 Dispatcher Positions



#### "Across the Board" Cuts

- Generally recognized as an imperfect budgeting practice
- Such cuts:
  - Are indiscriminate
  - Treat the highest priorities the same as the lowest
  - Violate the principle of merit and ignore life safety considerations
  - Penalize departments which have stepped up in the past to make cuts



## A True 10% *Across the Board*Cut is Unachievable

- Only 60% of the Sheriff's Department Operations are funded by the General Fund
- Contract Cities, Court Services, Grant funded positions cannot be cut
- 40% of all deputy sheriffs are funded by contracts and grants



#### A 10% Cut Would:

• Result in Disproportionate Loss of Service to Unincorporated Areas

 Reduce Jail Capacity in already undersized and overcrowded jail system

• Have many other adverse impacts...

- Longer Response Times
- Differential Call Responses
- Increased Crime Rate as Recession Deepens
- Decreased Officer Safety
- Increased Jail Overcrowding
- Degradation of Emergency Medical System
- Loss of Investment in our Deputies

Net result = Decreased Public Safety & Quality of Life



## Sheriff's Department Proposed Actions

- Maintain Hiring Freeze
- Continue Effective Overtime Management
- Offer \$1-2 Million in FY 09/10 Budget Reductions
  - Hold Positions Vacant
  - Reorganize Department
  - Civilianize Certain Sworn Positions
  - Outsource Services

#### Recommendations to the Board

- Identify Public Safety as the <u>Top Priority</u>
- Direct maximum effort towards Grant and Stimulus funds acquisition
- Require Collaboration
  - i.e., Task Forces, Day Reporting Center,
     Aviation
- Utilize Reserves and Designations
