The projects or activities identified below are determined to be exempt from further environmental review requirements of the California Environmental Quality Act (CEQA) of 1970, as defined in the State and County Guidelines for the implementation of CEQA.

**Project Title:** Cachuma RV Area Renovation

**Project Description:** This project involves the demolition and replacement of the existing underground utilities, concrete RV pads, fencing, asphalt road and restroom/shower facility in areas within the same general footprint of existing. Minor grading, trenching and site work will occur to accommodate the renovated utilities and facilities. All required utility services are currently present. Landscape and recreational improvements will occur with existing mature landscaping protected in-place.

**Exempt Status:**

Categorical Exemption

**Cite specific CEQA Guideline Section(s):** 15302, 15304 & 15301

**Reasons to support exemption findings (attach additional material, if necessary):**

CEQA Guideline Section 15302 Class 2 consists of the replacement or reconstruction of existing structures and facilities where the new structure will be located on the same site as the structure replaced and will have substantially the same purpose and capacity as the structure replaced.

CEQA Guideline Section 15304 Class 4 consists of minor alterations in the condition of the land, water and/or vegetation, including the replacement of existing conventional landscaping with water efficient landscaping, which does not involve removal of healthy, mature, scenic trees.

CEQA Guideline Section 15301 Class 1 consists of the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of existing use.

While certain areas of the 6,455-acre Cachuma Lake Park contain archaeological and biological areas of sensitivity, the immediate area where the RV campground is located does not, is well disturbed and has been for decades. The utilities already exist underground and the project limits will contain the new ground disturbance. The exemption is not limited by factors set forth in CEQA Guidelines Section 15300.2 as the maintenance activities are a Class 1 exemption, do not have a cumulative impact, significant effect on the environment due to unusual circumstances, impact on a scenic highway(s), nor impact on historical resources, and the maintenance activities are not on a hazardous waste site.
