The Appellant, the Santa Barbara Coalition for Responsible Cannabis (SBCRC), has withdrawn the Appeal (Case No. 21APL-00000-00020) of the Autumn Brands, LLC and Ocean Hill Farms, LLC Cannabis Cultivation Project on August 16, 2021. As a result of the Appellant's withdrawal of the appeal, the Planning Commission's approval, dated April 28, 2021, of Case Nos. 20DVP-00000-00011 and 20CDP-00000-00079 is final.

#### Recommended Action

- a) Acknowledge the withdrawal of the Appeal (Case No. 21APL-00000-00020) of the Planning Commission's approval, included as Attachment 1, and that upon acknowledgement of the withdrawal of the Appeal, the Planning Commission's approval of Case Nos. 20DVP-00000-00011 and 20CDP-00000-00079 constitutes the County's final action on the Permits;
- b) Acknowledge that upon withdrawal of the Appeal, there is no action for the Board of Supervisors to take on the substance of the Permits or Appeal and drop the item from the Board of Supervisor's agenda; and
- c) Determine that the above action is exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15378(b)(5).
