## RESOLUTION COMMENDING CAROLYN MAUSLEY UPON HER RETIREMENT MARCH 14, 2023

*WHEREAS, on February 5, 1990, Carolyn Mausley began her remarkable 33 year career with Santa Barbara County Department of Social Services as a Social Services Worker in the Child Welfare Services Division and excelled as a social worker providing responsive case management, court intervention, and emergency response services, including after-hours for both Child Welfare and Adult Services, and was named Social Worker of the Year in 1992 by the Central Coast Foster Parents Association; and*

*WHEREAS, Carolyn's contributions to Child Welfare Services include individual impacts to the children and families she assisted, her legacy also shaped the program we have in place today by piloting the Voluntary Family Preservation program and the Santa Barbara County Child Abuse Reporting Hotline; and,*

*WHEREAS, in 1998, as part of the Staff Development Division, Carolyn helped launch the automated Child Welfare Services Case Management System by training and supporting end users and in 1999, she promoted to Information Systems Coordinator in the Systems Division developing and maintaining automated tools and reports for Child Welfare Services staff; and*

*WHEREAS, in 2003, Carolyn's reach expanded to include the public assistance programs when she participated in the planning, implementation, and support of the CalWORKs Information Network (CalWIN) system as a member of the CalWIN Implementation Division, work that continues today through her involvement with the implementation of the California Statewide Automated Welfare System (CalSAWS) which will replace CalWIN; and*

*WHEREAS, for the past 19 years Carolyn has worked as a Computer Systems Specialist II in the Security & Systems Administration Unit implementing many other automated systems and providing support to countless Department of Social Services employees where she has proven herself to be a vital asset and an invaluable member of the County workforce, her willingness to serve and assist others and her "paying it forward" approach to mentorship on full display; and*

*WHEREAS, Carolyn's curiosity, quick-wit, clever expressions, and generous heart will be missed, she will now have time to devote to her other life's passions including being her best self by staying physically fit, getting outdoors whenever possible, connecting with loved ones, enjoying creative pursuits like restoring her cars, writing children's stories, sailing, and island-hopping in the Caribbean, and to explore yet undiscovered hidden talents and new passions.*

**NOW, THEREFORE, BE IT AND IT IS HEREBY ORDERED AND RESOLVED** that this Board of Supervisors recognizes her 33 years of service to the communities of Santa Barbara County, honors, commends and congratulates Carolyn Mausley upon her retirement on March 17, 2023.
