WITH REFERENCE TO THE FOLLOWING:

- A. On January 7, 1980, by Resolution No. 80-12, the Board of Supervisors of the County of Santa Barbara adopted the Santa Barbara County Coastal Land Use Plan; and
- B. On July 19, 1982, by Ordinance 3312, the Board of Supervisors of the County of Santa Barbara adopted the Santa Barbara County Coastal Zoning Ordinance, Article II of Chapter 35 of the Santa Barbara County Code; and
- C. The Board of Supervisors, having found it in the public interest to provide orderly development of the County and important to the preservation of the health, safety, and general welfare of the residents of the County adopted an ordinance (Exhibit 1) amending the Coastal Zoning Ordinance (Case No. 17ORD-00000-00010), of Chapter 35, Zoning, of the Santa Barbara County Code, to implement new development standards, permit requirements, and procedures regarding commercial cannabis activities, and make other minor clarifications, corrections, and revisions to the Santa Barbara County Local Coastal Program.
- E. The Board of Supervisors held duly noticed public hearing, as required by Section 65856 of the Government Code, on the amendment referenced above, at which hearing the amendment was explained and comments invited from the persons in attendance.
- F. This amendment to the Local Coastal Program is consistent with the provisions of the Coastal Act of 1976, the Santa Barbara County Coastal Land Use Plan, and the requirements of State planning and zoning laws as amended to this date.
- G. The Board of Supervisors now wishes to submit this amendment to the California Coastal Commission for certification.

NOW, THEREFORE, IT IS HEREBY RESOLVED as follows:

- 1. The above recitations are true and correct.
- 2. Pursuant to the provisions of 65857 of the Government Code and Section 30514 of the Public Resources Code, the above described changes have been adopted as an amendment to the Santa Barbara County Local Coastal Program.
- 3. The Board of Supervisors certifies that this amendment is intended to be carried out in a manner fully in conformity with the California Coastal Act.




