**FIRST AMENDMENT TO  
AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR  
BY AND BETWEEN  
COUNTY OF SANTA BARBARA  
AND  
PEGASUS STUDIOS**

**THIS FIRST AMENDMENT** (“First Amendment”) to Agreement for Services of Independent Contractor is made by and between the County of Santa Barbara, a political subdivision of the State of California (“County”), and Pegasus Studios, a California corporation (“Contractor”) registered to do business in California, whose principal place of business is located at 5760 Lindero Canyon Rd., #1151, Westlake Village, CA 91362.

**WHEREAS**, the County and Contractor are parties to that certain **Agreement for Services of Independent Contractor BC23207** dated November 28, 2023 (“Agreement”); and

**WHEREAS**, the County and Contractor desire to amend the Agreement to increase the total amount of compensation payable thereunder.

**NOW, THEREFORE**, in consideration of the mutual covenants set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, County and Contractor agree to amend the Agreement as follows:

- I. Section A of Exhibit B to the Agreement is hereby amended by replacing Section A of Exhibit B to read in its entirety as follows:  
“For CONTRACTOR services to be rendered under this Agreement, CONTRACTOR shall be paid a total contract amount, including cost reimbursements, not to exceed **\$191,500.00** (“Maximum Contract Amount”).”
- II. Effectiveness of Agreement. Except as expressly modified by this First Amendment, all of the terms and conditions of the Agreement remain in full force and effect.
- III. Authority. Each of the parties hereto represents and warrants that such party’s respective signatories to this First Amendment have the power and authority to enter into this First Amendment in the capacities set forth in such party’s signature block(s), below, and such party has fully complied with all formal requirements necessary for such party to enter into this First Amendment, and for this First Amendment to be legally binding on such party. Contractor hereby certifies and warrants that entering into this First Amendment shall not cause Contractor to breach the terms or conditions of any other contract or agreement to which Contractor is a party or which is otherwise binding on Contractor.
- IV. Counterparts. This First Amendment may be executed in several counterparts, all of which taken together shall be deemed to be originals and shall constitute a single agreement between the parties hereto.






