Summary Text:

This project consisted of improvements to circulation and parking, landscaping and irrigation, and street lighting on Ortega Hill Road and Lillie Avenue in the First Supervisorial District.

The project provided improvements for vehicle, bicycle and pedestrian circulation with the construction of new pavement, sidewalks, curb, gutter, pedestrian ramps and delineated bike lanes. Other improvements include decorative streetlights, landscape accented raised medians and parkways, major drainage facilities, and parking spaces.

The Director of Public Works accepted this project as complete on March 30, 2009. The project was completed within the budgeted amount.

Background:

The project location was between Valencia Road and Evans Avenue on Ortega Hill Road and Lillie Avenue in the town of Summerland. The purpose of the project was to improve the pedestrian, vehicular and bicycle circulation by constructing curb, gutter, and sidewalks, delineating a bike lane and by adding parallel and angled parking where feasible.

Fiscal and Facilities Impacts:

The total construction cost for this project is \$1,599,688.46, funded entirely by the State Transportation Improvement Program (STIP).
