

Rethink **Key Site 3**

WE NEED A BETTER PLAN

Key Points

- Follow the Orcutt Community Plan
 - Use Oakbrook Lane, not Chancellor
 - **Oakbrook Lane supports the project, and is the road the community plan calls for**
 - Chancellor is a gated 65-acre neighborhood with 11 homes on private road. Neighborhood not equipped to handle increased traffic and density.
 - MRO needs relocated to stay true to the Orcutt Community Plan
 - More suitable locations in Orcutt
 - Density concerns with leaving MRO at KS3
- Traffic congestion on Stillwell and Clark
 - Needs traffic lights
 - Stillwell not equipped to handle these many trips
 - 3 accidents on Stillwell in last year
- Opposition to this project is not from a few neighbors as developer says.
 - Attached are people from the community who signed up on the website
 - Developer's plan was so disliked in the community he took his Key Site 3 website down, as it was doing him more harm
 - Not opposed to growth, just want smart growth

I'm generally not opposed to new development. New development usually brings in more people which in turn bring in more commerce. The problem I have with this development as proposed is that when the MRO was placed on Key Site 3 the planning commission should have revised the Orcutt Community Plan to reflect the additional units being placed there. The original Orcutt Community Plan stated that if a developer acquired the 146.49 acres of land that is Key Site 3 and donated the 91 acres of land to the county for open space the zoning may be changed to PRD, with secondary emergency only access from Oakbrook Lane. Allowing for 125 units to be constructed on the remaining 55.49 acres, making it about a home for almost every ½ acre. This would have created a nice small ranchette feel to the gateway of our community. Once the MRO was placed on KS3 it presented a situation where the developer only had a few acres to build this many units, making the development not fit for the existing neighborhood. Once the density became so compact the proposed development no longer could use a secondary emergency access road, and require a full-time secondary access road, and pushed it down to Chancellor. This proposed development now is for 119 homes starting at 1,000sq feet and 3,000 square feet of land. The Santa Barbara County Code – Chapter 35 J. on page 2-34 MR-O zone states "The regulations will ensure project located in this zone will provide safe, aesthetically pleasing and desirable new residential neighborhoods that are compatible with existing developments." Let's look at this... My home at 5594 Hamilton Lane and has a property line that is only 100 feet away from where they are proposing to access Chancellor Road. My home sits on just under 5¼ acres and has a square footage of just under 7,000sq feet. By having the MRO here, you have pushed the developer to propose a development that is not compatible with my neighbors or my home. I bought in this neighborhood because we value our privacy, and people who have lived in the Santa Maria Valley for their whole lives don't even know this area exists. Allowing secondary access on Chancellor thru our gated entry to a community of 269 units on 17 acres of land will forever destroy this exclusivity.

The easement the applicant has is from the 1980's for access and public utility, the land at that time was zoned RR10. The owners who provided the easement would not have granted it for the zoning proposed.

In closing I would like to present that we not approve this development as proposed as we can't look this and the MRO separately, they together make one project. We take the time investigate the feasibility of moving the MRO to another location or revising the Orcutt Community plan with the MRO in place, so it will fit the surrounding existing developments.
