## **Recommended Actions:**

That the Board of Supervisors of the County of Santa Barbara:

- a) Appoint a single member to the Oversight Boards of each of the following Successor Agencies to the former Redevelopment Agencies within the County of Santa Barbara pursuant to Health & Safety Code Section 34179(a)(1) as follows:
  - i. Appoint Assistant County Executive Officer Jeff Frapwell to the Oversight Board of the Successor Agency to the former City of Santa Barbara Redevelopment Agency.
  - ii. Appoint Assistant County Executive Officer Jeff Frapwell to the Oversight Board of the Successor Agency to the former City of Lompoc Redevelopment Agency.
  - iii. Appoint Assistant County Executive Officer Jeff Frapwell to the Oversight Board of the Successor Agency to the former County of Santa Barbara Redevelopment Agency.

That the Board of Supervisors, <u>acting as the Board of Directors of the Santa Barbara County Fire</u> Protection District:

b) Appoint a single member to the Oversight Boards of each of the following Successor Agencies to the former Redevelopment Agencies within the County of Santa Barbara pursuant to Health & Safety Code Section 34179(a)(3) as follows:

- i. Appoint Assistant County Executive Officer Jeff Frapwell to the Oversight Board of the Successor Agency to the former City of Buellton Redevelopment Agency.
- i. Appoint Assistant County Executive Officer Jeff Frapwell to the Oversight Board of the Successor Agency to the former City of Goleta Redevelopment Agency.

#### **Summary Text:**

There were are (7) Successor Agencies to former Redevelopment Agencies located within the County of Santa Barbara for which Oversight Boards were have been formed including the City of Buellton, City of Goleta, City of Guadalupe, City of Lompoc, City of Santa Barbara, City of Santa Maria and the County of Santa Barbara (Isla Vista project area). The Buellton Successor Agency has been dissolved and its Oversight Board no longer exists. Each Oversight Board consists of seven members. A Matrix showing the eurrent members of the six (6) remaining seven (7) RDA Successor Agency Oversight Boards, including the six (6) eight (8) existing vacancies, is included with this Board letter as Attachment B. Today's action by your Board will fill four five of the six eight vacancies.

#### **Background:**

As a result of his retirement, former Budget Director Tom Alvarez's service on the RDA Successor Agency Oversight Boards came to an end. He had served on the RDA Successor Agency Oversight Board for the City of Lompoc, the City of Santa Barbara and the County of Santa Barbara (Isla Vista). Former Budget Director Tom Alvarez also served as a special district representative (on behalf of Santa Barbara County Fire Protection District) on the RDA Successor Agency Oversight Board for the City of Buellton and the City of Goleta.

Your Board's action today, as well as your Board's action as the Board of Directors of the Santa Barbara County Fire Protection District, will fill all the vacancies left by former Budget Director Tom Alvarez.

Applications for Successor Agency Oversight Board service have been received from the following individuals:

- Assistant County Executive Officer Jeff Frapwell applied to represent the County of Santa Barbara and serve on the City of Lompoc, City of Santa Barbara and County of Santa Barbara Successor Agency Oversight Board (Isla Vista).
- Assistant County Executive Officer Jeff Frapwell applied to represent the Santa Barbara Fire Protection District and serve on the City of Buellton and City of Goleta Successor Agency Oversight Boards.

Applications for Assistant County Executive Officer Jeff Frapwell are included with this Board Letter as Attachment A. Staff recommends you act to fill these positions as detailed above. A matrix of current appointed members to each of the Oversight Boards is available on Attachment B.
