Consider amending the 2012 meeting schedule of the Board of Supervisors by changing the location of the regularly scheduled meetings of September 11, October 9, November 13 and December 11, 2012 from Santa Maria to Santa Barbara.

#### **Summary Text:**

At the meeting of August 14, 2012, your Board authorized the initiation of renovations to the Joseph Centeno Betteravia Government Administration Building in Santa Maria. Construction activities are scheduled to begin on or around September 1, 2012. As a result, the Board Hearing Room in Santa Maria will be unavailable for use during construction that is expected to continue into the first quarter of 2013. Based on the current construction schedule, it is recommended that the Board meetings of September 11, October 9, November 13 and December 11, 2012 be moved from Santa Maria to the Board Hearing Room in Santa Barbara. All County departments and affected staff will be advised of this amendment to the meeting schedule as appropriate.

Looking forward, the 2013 meeting schedule will be considered in December, 2012. Any necessary adjustments to the 2013 schedule based on continuing construction activities will be considered at that time.

#### **Background:**

The Board of Supervisors 2012 schedule of meeting dates and locations was adopted on November 15, 2011. Based on business necessity, this schedule is amended as appropriate.
