## Alignment with Board Strategic Plan:

The recommendation(s) are primarily aligned with Goal No. 1, An Efficient Government Able to Respond Effectively to the Needs of the Community.

#### **Executive Summary and Discussion:**

On Thursday, July 3, 2003, five (5) bids were opened for the 2002/2003 Measure 'D' In Place Recycle of Vereda Cordillera near the City of Goleta and Roadway Rehabilitation of a Portion of Clark Avenue in the Town of Orcutt, in the Third and Fourth Supervisorial Districts of Santa Barbara County, County Project No. 820490. The lowest responsible bid was submitted by A. J. Diani Construction Company, a California corporation, in the amount of \$ 310,846.00, which was 15% below the Engineer's Estimate. Staff has performed an analysis of the bids received and has determined that the low bid is responsible and reasonable. Staff recommends awarding this contract to A. J. Diani Construction Company.

The project consists of an in-place recycle of Vereda Cordillera near the City of Goleta and a roadway rehabilitation of Clark Avenue in the Town of Orcutt. The in-place recycle project includes pulverizing the existing structural section, removing any excess material, re-grading and compacting the remaining structural section and paving with Type B asphalt concrete. The roadway rehabilitation project includes removal and repair of failed areas of the existing pavement and the placement of a Type B asphalt concrete overlay. Approximately 1.95 lane miles of County maintained roadway will be recycled and resurfaced with construction of this project.
