That the Board of Supervisors:

Set for public hearing on November 4, 2008, with 10-day public notice, consideration the adoption of the attached resolution designating the Sisquoc Store, located at 4960 Foxen Canyon Rd., Santa Maria, California (APN 129-202-003), as an historic landmark. The resolution is attached to this Board letter as Exhibit A, and the Nomination for Designation of Historic Landmark with supporting materials is attached as Exhibit B.

Summary Text:

On March 26, 2008, the Sisquoc Store was nominated by Greg Pfaus, the owner of the Sisquoc Store, for historic landmark status. At its regularly scheduled meeting on August 11, 2008, the Historic Landmarks Advisory Commission (HLAC) considered the nomination and determined that the Sisquoc Store is eligible for and worthy of protection as a historic landmark.

The property is owned by Greg Pfaus. Notice of this item's placement on HLAC's agenda for August 11, 2008 was given to the owner. Mr. Pfaus supports the landmark designation.

The Sisquoc Store has served as the small community of Sisquoc's general store and gas station for almost 100 years and is a familiar visual feature of the Sisquoc community and of Santa Barbara County. The store is identified with the 1910 Palmer oil boom in Cat Canyon and the gas station was one of the earliest in Santa Barbara County. The Sisquoc Store serves as one of the few remaining examples of early Twentieth Century rural western architecture in the County.

Upon achieving landmark status, the property will be subject to applicable sections of the County Code, Chapter 18A, and to the conditions set forth in the attached resolution.
