Summary Text:

The District's Conflicts of Interest Code amendments were adopted February 3, 2009. The amendments include new positions that must be designated.

Background:

All public agencies are required by the Political Reform Act of 1974 to:

- 1. Adopt local conflicts of interest codes identifying the reporting requirements of covered employees;
- 2. Review the need for any revisions to their local conflicts of interest codes on a biennial basis.

The revised Conflicts of Interest Code would be effective once approved by your Board.

SOLVANG ELEMENTARY SCHOOL DISTRICT CONFLICT OF INTEREST CODE

All members of the Solvang School District Board of Trustees, the Superintendent, the Principal, the Assistant Principal, the Maintenance/Operations Supervisor, the Bond Finance Consultant, the Business Manager and the Administrative Assistant to the Superintendent shall be responsible for completing a conflict of interest document. It has been determined that the positions listed herein manage public investments and will file a statement of economic interests pursuant to Government Code Section 87200: Superintendent. The document to be completed shall address conflict of interest in five different areas. This does not include the principal residence of the filer.

Category 1

Interests in real property located in the jurisdiction of the District with the fair market value of more than \$2,000.00.

Category 2

Business positions or investments from entities engaged in the appraisal, acquisition, or disposal of real property within the school district.

Category 3

Business positions, investments, or income of any type which has provided services, supplies, materials, machinery or equipment for the use of the school district.

Category 4

Business positions, investments or entities which within the previous two years has in any way attempted to use his or her official position to influence a governmental decision regarding services, supplies, materials, machinery or equipment to the school district.

Category 5

Business positions, investments, and business entities whose income are subject to the regulations imposed upon school districts.

The document completed by each Board of Trustee Member and Superintendent shall be forwarded to the Elections Division and a copy shall be retained by the District.

Preparation of said document shall allow Trustees and Superintendent time and a fair opportunity to present their views on conflict of interest questions.

Adoption of the conflict of interest code shall be posted where it can be viewed by the public at least ten days before a hearing to allow public input before adoption of the code. After the code is adopted, a copy shall be filed

with the Clerk of the Board of Supervisors, the Office of the County Counsel, and the Elections Division of the County Clerk Recorder.

A Board of Trustee Member and Superintendent need not report all investments or income that he or she may have. Investments may be reported only if they are in conflict with the five categories previously outlined. These forms shall be completed every two years or at that time in which a new Board of Trustee member assumes office.

Forms shall be those as prescribed by the California Fair Political Practices Commission and forms will be obtained from the Elections Division and are updated on an annual basis.

The designated trustee must disqualify himself or herself from participating in decisions that will have a reasonably foreseeable material affect upon the trustee, his or her immediate family, or in his or her financial interest. Disclosure of conflict includes the need for a trustee disqualification in instances where the interest may be for personal gain. The manner of disqualification shall be that as outlined in Title 2. The Fair Political Practices Commission, section 18732, article 334.9, which states as follows:

(9) Section 9. Manner of Disqualification. When a designated employee determines that he or she should not make a governmental decision because he or she has a disqualifying interest in it, the determination not to act must be accompanied by disclosure of the disqualifying interest. In the case of a voting body, this determination and disclosure shall be made part of the agency's official record; in the case of a designated employee who is the head of an agency, this determination and disclosure shall be made in writing to his or her appointing authority; and in the case of other designated employees, this determination and disclosure shall be made in writing to the designated employee's supervisor.

- **12.1(M)** Consideration for Approval: Consolidated Application for Funding Categorical Aid Programs, Part II. The Consolidated Application is submitted twice annually in order for the District to receive funds for categorical programs. The Con App was not available at the time of packet distribution. It will be available at the board meeting or can be viewed in the school office on Feb. 3.
- **12.2 (M)(*) Consideration for Approval: 2008 Proposition 39 Funding Performance Audit Report.** The annual Prop 39 Performance Audit examines the district's compliance with performance requirements for the Proposition 39/Measure B 02 General Obligation Bond. The report is prepared by the independent accounting firm Moss, Levy and Hartzheim.
- 12.3 (M) Consideration for Approval: Authorization to Open Bid the Bid Process on the Solvang Elementary Lower Campus New Classroom and Multi-Purpose Room Addition Project. The prequalification process will end on Feb 27 and prequalified bidders will be invited to bid on the pending project.
- 12.4 (R)(*) Consideration for Approval: Resolution 09-0203-1 Approval of Behavioral Intervention Plans Mandated Cost Claim Settlement and Agreement to Waive Future Claims. By accepting revenue generated by this class action suit the district waives its right to future mandated cost reimbursement. Currently Behavioral Intervention Plans do not fall under funded mandates.
- 12.5 (R)(*) Consideration for Approval: Resolution 09-0203-2 Approval of the Solis Group for the Department of Industrial Relations Approved Third Party Provider for Labor Compliance Services. The district will utilize the Solis Group to initiate and enforce statutory labor compliance requirements in conjunction with Bond construction.

- 12.6 (M) Consideration for Approval: Teaching Assignments for Mary Ann Ibsen and Bruce Pedersen Under Ed Code 44256. Education Code 44256 allows elementary credentialed teachers to teach departmentalized classes in Grade 8 and below with Board approval if they have completed 12 semester units or 6 upper division/graduate unites in the specified subject area.
- **12.7 (M)(*)Consideration for Approval: 2009-2010 Academic Calendar.** The Superintendent recommends the calendar as presented for the 2009-10 school year.
