

FOURTH AMENDMENT TO AGREEMENT

between

COUNTY OF SANTA BARBARA

and

AMERISOURCEBERGEN DRUG CORPORATION

for

PHARMACEUTICAL DISTRIBUTION SERVICES

Effective January 13, 2015

THIS IS THE FOURTH AMENDMENT (hereafter referred to as the Fourth Amendment) to the Prime Vendor Agreement for distribution services for pharmaceuticals and other products for the Public Health Department (PHD) Pharmacies, (hereafter Agreement), by and between the County of Santa Barbara (hereafter Customer) and AmerisourceBergen Drug Corporation (hereafter ABDC) and

WHEREAS, the Agreement is effective through June 18, 2015; and

WHEREAS, the Parties wish to amend the agreement to add another participating Walgreens pharmacy location in Santa Barbara County; and

WHEREAS, this Fourth Amendment incorporates the terms and conditions set forth in the Agreement of December 1, 2007 and all subsequent Amendments approved by the County of Santa Barbara, except as modified by this Fourth Amendment to the Agreement.

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein, the parties agree as follows:

1. **Amendments.**
 - a. **EXHIBIT 4** to the Agreement is deleted in its entirety and replaced with the attached Exhibit 4, which is attached hereto and incorporated herein by reference.
2. **Counterparts.** This Fourth Amendment may be executed in several counterparts, all of which taken together shall constitute a single agreement between the parties.
3. **Ratifications.** The terms and provisions set forth in this Fourth Amendment shall modify and supersede all inconsistent terms and provisions set forth in the Agreement. The terms and provisions of the Agreement, as expressly modified and superseded by this Fourth Amendment, are ratified and confirmed and shall continue in full force and effect as legal, valid, binding and enforceable obligations of the parties.
4. **Counterparts.** This Fourth Amendment may be executed in several counterparts, all of which taken together shall constitute a single agreement between the parties.
