SUBJECT: **Proposed Establishment of 1-Hour Parking Zones and a Permit-Parking Area on Crestmont Court and Crestmont Drive in the Orcutt Area; Fourth Supervisorial District.**

RECOMMENDATIONS:

That the Board of Supervisors adopt a resolution establishing 1-Hour parking zones on Crestmont Court and Crestmont Drive in effect Monday through Friday, excluding holidays, from 8:00a.m. to 5:00p.m. along with preferential permit-parking privileges to exempt vehicles displaying a valid parking permit on certain streets surrounding Righetti High School.

ALIGNMENT WITH BOARD STRATEGIC PLAN

EXECUTIVE SUMMARY AND DISCUSSION

A concern from a local resident regarding the recent resolution establishing permit-parking on several streets surrounding Righetti High School led to a more detailed analysis of the signature petition that was submitted for Crestmont Court and Crestmont Drive.

The County has worked closely with the community to establish permit-parking zones in the vicinity of Righetti High School. In our original analysis, the County requested a petition from the surrounding neighborhood. Based on that petition, the neighborhood was divided up into several areas. If the approval rate were 67% or greater, then permit-parking parking would be recommended for that area. Although the area which included Crestmont Court and Crestmont Drive only received a 42% approval rate, a much higher approval rate of 68% from Crestmont Court and Crestmont Drive from Larch Avenue to Redwood Avenue resulted when analyzed separately.

Based on these results, the Public Works Department recommends the establishment of 1-Hour parking zones in effect Monday through Friday, excluding holidays, from 8:00 a.m. to 5:00 p.m. along with preferential permit-

parking privileges to exempt vehicles displaying a valid parking permit at the following locations:

Crestmont Court, along both sides from the centerline of Crestmont Drive to the easterly terminus

Crestmont Drive, along both sides from the centerline of Larch Avenue to the centerline of Redwood Avenue

All of the property owners in the affected area were notified by mail of this recommendation.

MANDATES AND SERVICE LEVELS

No mandates or service levels are affected by this action.

FISCAL AND FACILITIES IMPACTS

The Parking Permit Program will consist of labor and equipment usage cost, purchasing signs and signposts, which will cost approximately \$1,165.00 of which \$142.50 will be used to produce the permits (about 3 permits per residence). Funding for this project has been budgeted in Department 054, Program 2900, Organization Unit 0002, Fund 0015, and Account 7511. These funds will be allocated through the Fourth District Supervisor Improvements and Projects and Measure "D" ½ Cent line item. This project was approved in the Santa Barbara County Operating Plan for FY 2002/03, Page D-292.
