#### **Recommended Actions:**

That the Board of Supervisors accept and file the Certification of Results of the Official Canvass and Official Election Summary for the South Coast Annexation to the Carpinteria Sanitary District Election held on April 22, 2008, as required by law or routine business necessity.

#### **Summary Text:**

Elections Code Sections 15372 and 15400 mandates that the Registrar of Voters complete an official canvass of the election and submit the results to the governing body within 28 days. The canvass was completed on May 16, 2008.

As required by Election Code Section 15372, a signed and sealed Certificate of Election Results of the Official Canvass (Attachment A) and an Official Election Summary is attached (Attachment B). The Certificate of Election results has been provided to LAFCO.

With the certification of the election results by the Registrar of Voters, the final date for any registered voter to request a recount of the results of this election was May 21, 2008 (Elections Code Section 15620).

Should any member of the Board of Supervisors of the public want more detailed election results by precinct, the Statement of Votes Cast for this election is available from the Elections Division.
