RE: Letter dated August 31, 2010 from Joseph E. Holland, County Clerk, Recorder and Assessor; Registrar of Voters, County of Santa Barbara, California (Recommend Appointees to Fill Vacancy) to Vandenberg Village Community Services District

Per the referenced letter the following is a brief description of my qualifications for office.

- To prepare myself for public service and to become familiar with the functioning of Santa Barbara County government, I volunteered and was selected by the Superior Court to be a member of the county Grand Jury for the 1997 – 1998 term. This primarily involved civil government oversight and complaint investigations.
- I have served continuously as a director of the Vandenberg Village Community District (VVCSD) since my election to the Board of Directors on November 5, 2002.
- VVCSD has three officer positions that are filled by election of the board members and those offices are President, Vice President and Finance Officer. I have served in all three capacities and am currently Vice President of our Board of Directors.
- The district has three standing committees: Finance/Budget, Legal/Personnel, and Water/Wastewater. I have served on all three committees and am currently the chairperson of the Legal and Personnel Committee.

- There are four primary outside agencies in which VVCSD participates, and they are the Association of California Water Agencies (ACWA) & ACWA/Joint Powers Insurance Authority (JPIA), California Special Districts Association (CSDA), Santa Barbara County Special Districts Association, and Santa Ynez Water Conservation District. I have represented the district before these outside agencies, served on the CSDA Planning Committee in 2007, and functioned as an Outreach Ambassador for ACWA. Currently I am an Executive Board Member of the Santa Barbara CSDA.
- It is the district's mission to "efficiently provide dependable drinking water delivery and wastewater collection services to Vandenberg Village residents, with a commitment to customer service." To provide added value to these mission requirements, I have participated in several initiatives and sparked a few that are either ongoing or have been successfully completed. Some examples are (Number two is still in process.):
 - (1) Water and Wastewater Rates inevitably increase due to inflationary economic pressures and other factors – The F&B committee recommended developing a gently upward sloping rate increase profile that was adopted into the budgeting process to ease the burden on ratepayers,
 - (2) To increase the district's sphere of influence to encompass existing real property holdings and an additional land area necessary to accommodate a photovoltaic facility to provide solar power for the district,
 - (3) Establish a strategic planning objective to improve water quality, primarily through a pellet-softening project to reduce hard water content in treated water, and
 - (4) To provide an incentive to save water by establishing a fourth and higher tier to the district's water rate structure that would help reduce potentially unnecessary water consumption. This new rate was implemented in July of 2009 and the district is now successfully realizing a reduction in high end users.
- Finally, every year at this time the district is subject to an annual audit by an independent audit firm that has revealed no financial indiscretions by any member of the board during my terms in office. In addition, I, like my fellow board members,

must take initial and recurring ethics and sexual harassment training to insure that we all meet government code requirements. We are in compliance with these requirements and also the Ralph M. Brown Act.

The above summarizes my qualifications for the office of director of the Vandenberg Village Community Services District and that I meet and observe all standards of integrity.
