FIRST AMENDMENT

Effective May 1, 2012

THIS IS THE FIRST AMENDMENT (hereafter referred to as **First Amendment**) to the Agreement for an Offender Monitoring System, number BC-12-052 (hereafter **Agreement**), by and between the County of Santa Barbara (COUNTY) and G4S Justice Services, LLC (CONTRACTOR), for the provision of an Offender Monitoring System for the County of Santa Barbara Probation Department.

WHEREAS, the Agreement is effective through June 30, 2014; and

WHEREAS, Sentinel Offender Services, LLC acquired G4S Justice Services, LLC on May 1, 2012 taking over all its duties and obligations generally, and specifically those duties and responsibilities under the terms and conditions of the Agreement, BC-12-052; and

WHEREAS, the parties desire to amend the Agreement to reflect the acquisition of G4S Justice Services, LLC by Sentinel Offender Services, LLC, including updating the provisions of the Agreement regarding Designated Representative and Notices; and

WHEREAS, this First Amendment incorporates the terms and conditions set forth in the Agreement approved by the County of Santa Barbara, BC-12-052.

NOW, THEREFORE, the Agreement is Amended as follows:

a. **Amendments to Agreement.**

This Agreement (hereafter Agreement) is made by and between the County of Santa Barbara, a political subdivision of the State of California (hereafter COUNTY) and Sentinel Offender Services, LLC, having its principal place of business at 201 Technology Drive, Irvine, CA 92618 (hereafter CONTRACTOR).

1. **DESIGNATED REPRESENTATIVE.** Brian Swanson at phone number (805) 934-6273, is the representative of COUNTY and will administer this Agreement for and on behalf of COUNTY. Kevin Nelson at phone number (253) 853-2061 is the authorized representative for CONTRACTOR. Changes in designated representatives shall be made only after fifteen (15) days advance written notice to the other party.

2. **NOTICES.** Any notice or consent required or permitted to be given under this Agreement shall be given to the respective parties in writing, by first class mail, postage prepaid, or otherwise delivered as follows:

b. **Ratifications.** The terms and provisions set forth in this First Amendment shall modify and supersede all inconsistent terms and provisions set forth in the Agreement. The terms and provisions of the Agreement, as expressly modified and superseded by this First Amendment, are ratified and confirmed and shall continue in full force and effect, and shall continue to be legal, valid, binding, and enforceable obligations of the parties.

c. **Counterparts.** This First Amendment may be executed in several counterparts, all of which taken together shall constitute a single agreement between the parties.






