Re: Draft Environmental Justice Element

Dear Vice Chair Reed and Commissioners,

The Santa Barbara County Riding and Hiking Trails Advisory Committee (CRAHTAC) is writing to you regarding the proposed **Draft County Environmental Justice Element**. We aim to provide focused recommendations on ideas to improve this draft document, specifically concerning the importance of trails and outdoor recreation to environmental justice communities and the health and welfare of affected residents.

As the Planning Commission is aware, CRAHTAC is a standing committee appointed by the Santa Barbara County Board of Supervisors to advise the County on projects and policies related to the County's trail system and trail users. We respectfully request that the Planning Commission require amendments to the draft Environmental Justice Element to address the following:

- 1) Acknowledge the Importance of Trails and Outdoor Recreation to the Health and Welfare of Environmental Justice/Disadvantaged Communities: These communities are known to suffer disproportionately from a range of adverse health conditions, including obesity and related diseases such as diabetes, high blood pressure, heart disease, etc. The revised Environmental Justice Element should describe and provide data on these health-related issues and the known importance and benefits of free or low-cost public trails, parks, and outdoor recreation to help alleviate such health concerns. The revised document should also clearly acknowledge that, as part of the 2024 Housing Element process, the County Board of Supervisors found that provision of public parks, trails, and recreation is essential to the public health and welfare, which also mirrors language in the County's adopted Park Development Impact Fee ordinance. The County's Draft Recreation Master Plan provides a discussion of these issues. As summarized below, the two documents should be thoroughly integrated and made consistent with each other as required under state law.
- 2) Fully Integrate the Draft Environmental Justice Element and Draft County Recreation Master Plan: The Draft Recreation Master Plan (RMP) provides substantial data on recreational use, activities, and demand, including that for disadvantaged or environmental justice communities, which should be reflected in the Draft Environmental Justice Element. This could include the

Environmental justice element, considering or highlighting if planning RMP recreational improvements are located proximate to serve existing known or potential future neighborhoods qualifying as environmental justice communities. Of particular importance is ensuring that the policies of the draft Environmental Justice Element are integrated into and are consistent with those that will be put forth as part of the Draft RMP. Policies that promote or require the provision of public trails and other outdoor recreation that are easily accessible to existing and new disadvantaged/environmental justice communities are key to helping address known health problems and increase equity. For example, the provision of readily accessible new public parks, recreation, and trails to serve new communities in the eastern Goleta Valley that may provide upwards of 1,000 new affordable housing units is key to improving the public health and welfare of these lower-income residents and often disadvantaged new residents. However, the full integration of these two documents will be challenging, as the RMP policies are apparently not expected to be released until two weeks after the Planning Commission's October 8, 2025, hearing on the Environmental Justice Element.

- 3) Include Policies Regarding Public Health and Trails/Outdoor Recreation in the Draft Environmental Justice Element: CRAHTAC members broadly supported the limited policy amendments recommended by the Santa Barbara County Trails Council (letter dated 8/25/25) and hope that the Planning Commission will as well. We further recommend that the Environmental Justice Element include the following two new policy concepts:
 - a) In order to maintain and improve public health and welfare, as part of all new developments containing substantial amounts of affordable housing, the County shall require the provision of onsite or nearby public parks, recreation, and trail opportunities to serve new residents and those of surrounding neighborhoods.
 - b) In order to maintain and improve public health and welfare, the County shall work with disadvantaged and environmental justice communities, community organizations representing such communities, and community recreational organizations to strive to improve the provision of new trails, public parks, and outdoor recreation within or adjacent to such communities.

Thank you for considering this input and request. We are excited about the Draft Environmental Justice Element and its potential benefits in helping to improve public health and welfare for disadvantaged or environmental justice residents through the provision of new or improved public trails and outdoor recreation.

On behalf of the Santa Barbara County Trails Council, I would like to express our strong support for the Draft Environmental Justice Element (EJE). We understand that the EJE focuses on the needs of disadvantaged communities and includes specific objectives aimed at improving the quality of life in the communities of Cuyama, New Cuyama, Ventucopa, Sisquoc, Garey, Casmalia, Los Alamos, and Isla Vista. Achieving environmental justice in outdoor recreation means ensuring that outdoor opportunities are fairly shared, that everyone is included in decision-making processes, and that natural spaces are welcoming and respectful to all. We are pleased to see that Santa Barbara County has outlined this vision in its Draft Environmental Justice Element, which highlights the importance of equitable access to nature and recreation for all communities.

Our focus is on creating new trails for various types of outdoor recreation, protecting public trail access, building and maintaining safe and sustainable trails, and promoting public engagement in land stewardship. Since 2010, we have helped create more than 30 miles of new public trails across the county. These trails are free, open to everyone, and highlight the incredible diversity of our region's landscapes. In a time when many environmental justice issues face significant challenges, this is a success story. It shows that steady, collaborative work can deliver real progress.

We urge the County to amend two policies to underscore the *importance of trail infrastructure* for access to outdoor recreation – a popular and free means for promoting an active lifestyle.

- **Policy 1: Promote Public Facilities in EJCs** This should include trail infrastructure as a public facility for recreation.
- Policy 3: Promote Physical Activity in EJCs This should emphasize trail access as a proven, affordable way to facilitate access to nature and encourage an active lifestyle.

Trails are key to achieving environmental justice in recreation, as they ensure that recreational opportunities are available to everyone (distributional justice) and that recreational spaces are welcoming and respectful to all users (interactional justice). Expanding trail access closer to disadvantaged communities would provide affordable and equitable opportunities for exercise, community connection, and time spent in nature.

I own a condo unit overlooking the North Campus Open Space. For the past 10 years I have rented the unit to visiting academics, professors and post docs. I recently rented it to a visiting professor who terminated her lease after a week due to unacceptable levels of noise emanating from The Cove.

My question is this: Given that planning approval was granted in 2020 for the construction of 32 'family' homes, probably housing no more than 4-6 people per unit, how has it come about that each unit now houses 10-12 'undergraduate students'. Both quantitatively and qualitatively this latter use is fundamentally different from that which was initially agreed. It is having a dire effect on the local residents and is significantly devaluing their properties. What is most distressing is that this development was allowed to happen without any consultation of the local residents whatsoever in what I can only characterize as a classic bait and switch scam. County Supervisors clearly dropped the ball on this one and owe us not merely an explanation but urgent remediation.
