Budget Action: Increase Appropriations of \$600,000 in Planning & Development, Planning and Development Fund for Services and Supplies funded by an operating transfer from the

General Fund. Increase Appropriations of \$600,000 in General County Programs General Fund for Other Financing Uses funded by release of Restricted UCSB LRPD

Settlement fund balance.

Justification: Approval of this budget revision in the amount of \$600,000 will provide budget authorization to enter into an agreement with 4LEAF, Inc. to provide substandard housing

inspection services for the Isla Vista Rental Housing Inspection Pilot Program, commencing on July 16,2025 through June 13, 2026 for a base Agreement amount not to

exceed \$535,600 plus a 5 percent contingency fund of \$26,780, totaling \$562,380. The residual \$37,620 represents related departmental enforcement costs,

cumulatively totaling \$600,000. The appropriation for this funding will be fully covered by the \$600,000 in designated funds from Santa Barbara County's Agreement with UCSB's Long Range Development Plan, currently set aside in the General County Program General Fund, Restricted UCSB LRDP Settlement fund balance. Therefore,

there are no fiscal impacts to the County.
