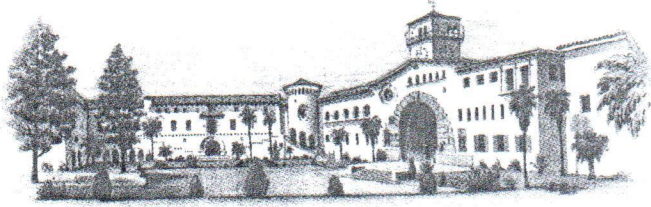

# COUNTY OF SANTA BARBARA CALIFORNIA

## RESOLUTION OF RECOGNITION TO LOMPOC FEDERAL CORRECTIONAL COMPLEX FOR SERVICES PROVIDED TO THE LOMPOC COMMUNITY

*WHEREAS, Community Service was performed as the Federal Prison Camp assigned eleven inmates for a total of four weeks to painting projects in the Auditorium, Trophy and Banquet Rooms, Kitchen, and the entranceway to both the American Legion Post 125 and VFW Post 1717 Club Rooms; and*

*WHEREAS, Community Service was performed as a historic ten-foot conference table and twelve chairs were refinished and reupholstered by the Prison Hobby Shop, located in the secure facility of the Complex. History indicates the conference table and chairs are associated with Major Max Fleischmann when he donated the historic Hill-Carrillo Adobe to the Santa Barbara Foundation in the 1930s; and*

*WHEREAS, Community Service was performed as an eight foot by four foot Mural of the historic World War II Flag Raising at Iwo Jima was painted by inmate Fulton Leroy Washington and supervised by staff member Will Russell in the secure facility of the Complex. The Mural is displayed in the Trophy Room; and*

*WHEREAS, Community Service was performed as an eight foot by two foot Mural of the Seals of the Military Services was painted by inmate Fulton Leroy Washington and supervised by Staff member Will Russell in the secure facility of the Complex. The Mural is displayed in the Kitchen; and*

*WHEREAS, Community Service was performed as a sixteen foot by four foot Mural was painted by Fulton Leroy Washington of the disaster at Honda Point on September 8, 1923. Seven United States Navy destroyers crashed on the rocks at Honda Point (off the coast near Vandenberg Air Force Base). Twenty-three sailors perished on the USS Delphy and the USS Young.*

*NOW THEREFORE IT IS HEREBY ORDERED AND RESOLVED that this Board of Supervisors recognizes and commends the Federal Correctional Complex, a correctional institution of the Federal Bureau of Prisons, an agency of the United States Department of Justice, for their commitment in aiding the restoration and preservation of the historic and patriotic Lompoc Veterans Memorial Building.*
