That the Board of Supervisors:

- A. Approve the plans and specifications for the San Marcos Road Storm Damage Repair at MP 0.7, County Project No. 862299;
- B. Award the construction contract for \$158,766.00 to the lowest responsive bidder, R. Burke Construction (not a local vendor) P.O. Box 957, San Luis Obispo, CA 93406, subject to the provisions of documents and certification as set forth in the plans and specifications applicable to the project and as required by law;
- C. Approve and authorize the Chair to execute the construction contract upon return of the Contractor's executed contract documents, and the review and approval of County Counsel, Auditor-Controller, Risk Manager or their authorized representatives; and
- D. Approve a contingency fund for \$15,876.60 for the San Marcos Road Storm Damage Repair at MP 0.7, County Project No. 862299.

Summary Text:

On Thursday, July 15, 2010, Public Works opened eleven (11) bids for the San Marcos Road Storm Damage Repair at MP 0.7. R. Burke Construction submitted the lowest responsive bid of \$158,766.00. This amount is 17% below the Engineer's Estimate. Public Works staff analyzed the bid and determined that it is responsive and reasonable, and recommends awarding this contract to R. Burke Construction.

The project is located on San Marcos Road, approximately 0.7 miles north of Cathedral Oaks Road. The project will repair damage caused by the 2005 storms by restoring the roadway shoulder and drainage to their pre-storm condition. Construction will include debris removal on the shoulder, constructing a barrier rail to restore the shoulder, and reconstructing a paved swale on the shoulder to restore drainage capacity.



San Marcos Road – Existing Conditions (Looking North)

The project will include traffic control and flagging, with delays up to 10 minutes during construction hours, from 8:00 a.m. to 5:00 p.m., Monday through Friday. The full roadway width will be open during non-working hours.

Background:

In January 2005, severe weather and intense rain deluged San Marcos Road. The massive runoff combined with weak rock, soil, and steep slopes caused severe erosion at the project site. A mud and debris slide fell over the roadway, making it impassible. County Maintenance forces acted quickly and moved the debris to clear the roadway; however, the roadway shoulder has remained impacted. The debris piled on the shoulder forces rainwater onto the roadway whereas, prior to the storms, water flowed to the ditch. This project will clear debris from the shoulder and restore proper drainage.

The project will involve constructing approximately 700 feet of barrier rail and replacing the buried swale with a 5-foot wide paved drainage swale. Water will drain into the existing inlet, enhanced with a new drainage grate.
