That the Board of Supervisors:

- A. Accept on behalf of the Public, pending recordation of Parcel Map No. 14,795, the offers of dedication for the Easements for Public Utility purposes as shown on said map, and authorize the Clerk of the Board to endorse the Parcel Map No. 14,795 accepting said Easements as defined on said map. Consummation of the acceptance of Easements for Public Utility Purposes is subject to recordation of the subject Map; and
- B. Determine that an action by the Board to accept said offers of dedication is exempt from CEQA pursuant to Section 15315 of the Guideline of Implementation of CEQA. The map was conditioned to offer said easements, therefore, the Board's action to accept the subject easement is similarly determined to be exempt from CEQA.

Summary Text:

The County Surveyor's Office is reviewing Parcel Map No. 14,795 (County Assessor Parcel Number 107-270-006) located at 4485 Hummel Drive in the Orcutt area, Fourth Supervisorial District.

Prior to the Clerk of the Board's endorsement on the subject Parcel Map, the County Surveyor will be satisfied that said Map is technically correct, conforms to the approved Tentative Map (or any approved alterations thereto), and complies with all applicable laws and regulations.

After the map has been found to be technically correct and all departments and utilities concerned with the processing of Subdivision Maps have certified that map is ready for recordation; and the payment of Real Property Taxes have been made or bonded for and deposited with the Clerk of the Board, the County Surveyor will present the Parcel Map to the Clerk for endorsement.

After the Clerk endorses its acceptance of said Public Utility Easements thereon, the County Surveyor will deliver the Parcel Map to the County Recorder for recordation.

Background:

At its regularly scheduled meeting on January 6, 2014 the Santa Barbara County Board of Supervisors met and approved Parcel Map 14,795 which was exempt from CEQA for the subject project. The Project, which included granting the subject easements to the County, was found exempt from environmental review pursuant to Section 15315 of the Guidelines for Implementation of the California Environmental Quality Act (CEQA). This section provides an exemption for the division of property in urbanized areas zoned for residential, commercial, or industrial use into four or fewer parcels when the division is in conformance with the General Plan and Zoning, no variances or exceptions are required, all services and access to the proposed parcel to local standards area available, the parcel was not involved in a division of a large parcel within the previous 2 year and the parcel's average slope is less than 20 percent.

After the County Surveyor is satisfied that all of the conditions of approval for Parcel Map No. 14,795 have been met and the payment of Real Property Taxes have been made or bonded for, he shall present the Map to the Clerk of the Board and request acknowledgement of the Board's acceptance of said Public Utility Easements thereon. Once the Map has been endorsed by the Clerk, the County Surveyor shall transmit it to the County Recorder's Office for recordation.
