CERTIFICATE OF FACTS

[Elections Code section 10515(a)]

I, Donna Glass, declare as follows:

I am the Secretary of the Board of Directors for the San Antonio Basin Water District and make this declaration pursuant to subdivision (a) of section 10515 of the Elections Code.

By 5:00 p.m. on August 8, 2025, the 88th day before the general district election scheduled to be held on November 4, 2025, only two (2) people filed a declaration of candidacy for each of the two elective offices to be filled at that election, and a signed petition, requesting that the general District election be held, has not been presented to any District representative or officer.

The District requests that the Santa Barbara County Board of Supervisors, at a regular or special meeting held prior to December 1, 2025, appoint the following named candidates to the office of director for the term ending December 2029:

Each candidate has filed a Declaration of Candidacy and all other required forms and materials on or before the date required by law. Each candidate has taken and subscribed to the Oath of Allegiance. Each candidate is a holder of title to land in the District or the legal representative of a holder of title to land in the District.
