# **Recommendation(s):**

That the Board of Supervisors:

That your Board appoint-in-lieu of election the persons listed in this letter, who were recommended for appointment by the Summerland Sanitary District and the Santa Maria Valley Water Conservation District, for the respective terms.

## **Executive Summary and Discussion:**

August 9, 2002 was the close of the nomination period for the November 5, 2002 Consolidated General Election. At that time no candidates had filed for one full-term position and two short-term positions for Director of the Summerland Sanitary District and one full-term position for Director of the Santa Maria Valley Water Conservation District, Division #3. Pursuant to Elections Code Section 10515, if an insufficient number of persons have filed a declaration of candidacy for an office, the district shall not hold an election unless there is filed with the elections official by the 83<sup>rd</sup> day before the election (August 14, 2002) a petition signed by 10% of the voters in the district requesting that the election be held. Since a petition was not filed with the elections official by the specified deadline, the Clerk-Recorder-Assessor, Elections Division must request that your Board appoint in-lieu of election those persons recommended by the Summerland Sanitary District and the Santa Maria Valley Water Conservation District. In accordance

with Elections Code Section 10515(b), the person(s) appointed shall qualify and take office and serve exactly as if elected at a general district election for the office.
