Executive Summary and Discussion:

This project consisted of removing and repairing approximately 976 square yards of failed areas in the existing pavement, cold planing approximately 31,622 square yards of existing pavement, placing approximately 60,580 square yards of pavement reinforcing fabric and placing an Type B asphalt concrete overlay on approximately 9 lane miles of County maintained roadway.

The contract was accepted on September 3, 2003, by the Director of Public Works as complete.

The project was completed on time and under the budgeted contract amount.
