### NOTICE

Each project applicant shall remit to the county clerk the environmental filing fee before or at the time of filing a Notice of Determination (Pub. Resources Code, § 21152; Fish & G. Code, § 711.4, subdivision (d); Cal. Code Regs., tit. 14, § 753.5). Without the appropriate fee, statutory or categorical exemption, or a valid No Effect Determination issued by the California Department of Fish and Wildlife (CDFW), the Notice of Determination is not operative, vested, or final, and shall not be accepted by the county clerk.

### COUNTY DOCUMENTARY HANDLING FEE

The county clerk may charge a documentary handling fee of fifty dollars (\$50) per filing in addition to the environmental filing fee (Fish & G. Code, § 711.4, subd. (e); Cal. Code Regs., tit. 14, § 753.5, subd. (g)(1)). A county board of supervisors shall have the authority to increase or decrease the fee or charge, that is otherwise authorized to be levied by another provision of law, in the amount reasonably necessary to recover the cost of providing any product or service or the cost of enforcing any regulation for which the fee or charge is levied (Gov. Code, § 54985, subd. (a)).

If this information is contained on the cash receipt filed with CDFW under California Code of Regulations, title 14, section 753.5, subdivision (e)(6), no additional information is required.

### DOCUMENT RETENTION

The county shall retain two copies of the cash receipt (for lead agency and county clerk) and a copy of all documents described above for at least 12 months.

### RECEIPT NUMBER

- # The first two digits automatically populate by making the appropriate selection in the County/State Agency of Filing drop down menu.

**PROJECT TITLE:** Public Safety Radio System Replacement

**PROJECT DESCRIPTION:** The County of Santa Barbara's Public Safety Radio System (PSRN) is at end of its vendor supported life and needs replacement. The PSRN users are: Fire, Sheriff, Public Health, Probation, Parks, General Services, District Attorney, and contracted cities. EF Johnson is designing and implementing the PSRN, which consist of the following major components:

- Land Mobile Radio (LMR) systems for Fire, Sheriff and EMS, and a Local Government (LG) system for Public Works, Public Health, Parks and General Services. LMR systems provide voice communications between radio users in the field and the Sheriff Dispatch Center (Dispatch) or other radio users via a mobile or portable radio (subscriber units) and the LMR base stations at radio sites throughout the County.
- The County Public Safety Microwave Radio System to carry radio user voice signals between the LMR base station sites and the Communications (Comm) Center where the system control equipment is located for all four County LMR systems.
- Dispatch where the dispatch consoles reside that allow the Sheriff / Fire dispatchers to dispatch on all three County LMR systems.

As set forth in more detail in the chart above, at each listed site work will either involve replacing existing equipment or adding new equipment, including a tower and shelter where indicated. Work at all the sites will involve replacing existing equipment will involve operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment or topographical features involving negligible or no expansion of existing or former use. Replacement or reconstruction work of existing structures or facilities will be located on the same site as the structure or facility replaced and will have substantially the same purpose and capacity as the replaced structure or facility. New construction and location of limited numbers of new, small facilities or structures and installation of small new equipment and facilities in small structures are also part of the project as detailed above. Lastly the project will include a contract with Federal Engineering, Inc. for consulting

services associated with technical implementation services management for the Public Safety Radio System Replacement Project.

**Cite specific CEQA Guideline Section:**

**Reasons to support exemption findings:** The proposed actions are exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to the following CEQA guidelines sections: 15301 as the actions consist of the operation, repair, maintenance, leasing, licensing or minor alteration of existing public structures, facilities, mechanical equipment or topographical features, involving negligible or no expansion of existing or former use; 15302 as the actions consist or replacement or reconstruction of existing structures and facilities located on the same site and with the same purpose and capacity; 15303 as the actions consist of construction and location of limited numbers of new, small facilities or structures and installation of small new equipment and facilities in small structures; and 15061(b)(3) as it can be seen with certainty that there is no possibility that the activity may have a significant effect on the environment.

The exceptions to the Categorical Exemptions pursuant to Section 15300.2 of the State CEQA Guidelines have be considered as follows:

- (a) *Location. Classes 3, 4, 5, 6, and 11 are qualified by consideration of where the project is to be located – a project that is ordinarily insignificant in its impact on the environment may in a particularly sensitive environment be significant. Therefore, these classes are considered to apply in all instances, except where the project may impact on an environmental resources of hazardous or critical concern where designated, precisely mapped, and official adopted pursuant to law by federal, state, or local agencies.*

The site locations identified above for application of the Class 3 exemption (Section 15303) are located outside of any designated or existing Environmentally Sensitive Habitat (ESH) areas. There are no other designated or mapped environmental resources of hazardous or critical concern on or adjacent to the project site. Therefore, no significant impacts that threaten the environment would result from the project.

- (b) *Cumulative Impact. All exemptions for these classes are inapplicable when the cumulative impact of successive projects of the same type in the same place, over time is significant.*

Due to the relatively low number of projected facilities and the need for the facilities to be spread around the County and not concentrated together, the cumulative impact of successive projects of the same type in the same place over time will not be significant. Therefore, this exception to the Categorical Exemption is not applicable to the proposed project.

- (c) *Significant Effect. A categorical exemption shall not be used for an activity where there is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.*

The proposed project does not involve unusual circumstances, including future activities, resulting in or which might reasonably result in significant effects on the environment. The proposed project will not result in a significant effect on the environment.

- (d) Scenic Highways. A categorical exemption shall not be used for a project which may result in damage to scenic resources, including but not limited to trees, historic buildings, rock outcroppings, or similar resources, within a highway officially designated as a state scenic highway. This does not apply to improvements which are required as mitigation by an adopted negative declaration or certified EIR.*

The project will not result in damage to scenic resources, including but not limited to trees, historic buildings, rock outcroppings, or similar resources, within a highway officially designated as a state scenic highway because, as noted above, most sites involve replacement of existing equipment at existing facilities or adding equipment to existing facilities that will either be located within equipment rooms or shelters or will blend in with other equipment. Where new structures are proposed, they will be of a relatively small scale that will not damage scenic resources. Therefore this exception to the Categorical Exemption is not applicable to the proposed Project.

- (e) Hazardous Waste Sites. A categorical exemption shall not be used for a project located on a site which is included on any list compiled pursuant to Section 65962.5 of the Government Code.*

None of the sites identified above are included on any list compiled pursuant to Section 65962.5 of the Government Code. Therefore, it is not located on a hazardous waste site and this exception to the Categorical Exemption is not applicable to the proposed Project.

- (f) Historical Resources. A categorical exemption shall not be used for a project which may cause a substantial adverse change in the significance of a historical resource.*

The proposed project will not cause a substantial adverse change in the significance of any historical resources. As noted above, most sites involve replacement of existing equipment at existing facilities or adding equipment to existing facilities and will not cause any substantial changes. Where new facilities or structures are proposed, there will be no substantial adverse changes in the significance of historical resources.

As described above, none of the exceptions to the categorical exemptions contained within Section 15300.2 of the State CEQA Guidelines apply to this Preliminary Project.
