**PROJECT DESCRIPTION:**

Approve and authorize the Statement of Final Quantities for work performed and materials supplied for this project by the Contractor. This project helped to rehabilitate and resurface unincorporated sections of Central Avenue, Betteravia Road, Clark Avenue, and Santa Maria Way. Approximately 2.2 lane miles of County maintained roads were resurfaced with this project. The total construction cost for this project was \$661,492.30.


