Recommended Actions:

That the Board of Supervisors approve and execute the attached Agreement for Professional Legal Services with Ice Miller LLP, a law firm in Indianapolis, Indiana, in an amount not to exceed \$6,000.00.

Summary Text:

This agreement covers Ice Miller's review of documentation related to the County's Retirement System and a two-day due diligence session consisting of interviewing staff members and identifying additional documentation for review concerning the Retirement System.

Following the due diligence session, Ice Miller will work with County staff to identify the specific goals and objectives of Ice Miller's engagement and create a more detailed scope of work with cost estimates, and the Agreement will be amended.

Background:

On November 7, 2006, Mercer Human Resource Consulting and Kroll Worldwide presented the Board of Supervisors with a Retirement System Evaluation report which identified several legal issues related to the Retirement System. Since the time of Mercer/Kroll's presentation, staff from the offices of the County Counsel, County Executive Officer, and Auditor-Controller identified and interviewed several employee benefits tax attorneys.

During the Board of Supervisors closed session meeting on January 16, 2007, staff recommended that the County obtain legal services from Ice Miller, specifically attorney Mary Beth Braitman, to address the legal issues identified in the Mercer/Kroll report. Ms. Braitman works with numerous public pension plans around the country on tax issues, plan design issues, plan qualification issues, IRS compliance issues, fiduciary issues, and health care issues. The Board of Supervisors authorized staff from the offices of the County Counsel, CEO, and Auditor-Controller to obtain legal services from Ice Miller.
