**Recommended Actions:**

That the Board of Supervisors:

- A. Approve and authorize the Chair to execute the Statement of Final Quantities for the FY 2010/2011 Proposition 1B Hot Mix Asphalt Overlay in the First, Second, and Third Supervisorial Districts for work performed and materials supplied by Granite Construction Company in the amount of \$1,196,556.58; and
- B. Find that the proposed action has no possibility of significant effect on the environment, that the proposed action is therefore exempt from CEQA pursuant to 14 CCR Section 15061 (b,3), and approve the filing of a Notice of Exemption on that basis.

**Summary Text:**

The project consisted of rehabilitating and resurfacing approximately 4.6 lane miles on sections of Channel Drive, San Ysidro Road, Patterson Avenue, and El Colegio Road with 13,431.26 tons of hot mix asphalt concrete overlay. Additionally, three pedestrian ramps and a concrete cross gutter were installed at the intersection of Camino Corto and Abrego Road to comply with the American with Disability Act (ADA) and to improve drainage.

The Director of Public Works accepted this project as complete on June 30, 2011. The project was completed on budget.

### **Background:**

The Board of Supervisors approved Prop 1B-LSR funds on June 1, 2010. As part of the State budget work, the State paid out the entire remaining three years of Prop 1B-LSR funds this year and for Fiscal Year 2010/11, and this project was selected to utilize a portion of these funds.

On June 15, 2010, your Board approved the Notice of Exemption pursuant to the County's California Environmental Quality Act (CEQA) guidelines.

On February 15, 2011, your Board awarded the above referenced construction contract to Granite Construction Company.
