Accept the Notice of Completion for work performed by the Contractor, D-Kal Engineering, Inc. (not a local vendor), Post Office Box 1919, San Luis Obispo, California, 93406, and authorize Clerk to Record.

Summary Text:

Construction of the 2009 American Recovery and Reinvestment Act (ARRA) Miscellaneous Concrete Repair project took place in the unincorporated areas of Goleta, Vandenberg Village, and Orcutt. This project installed 3,846.5 linear feet of new sidewalk on Clark Avenue in Orcutt, and repaired 1,830 linear feet of existing sidewalk in Goleta and Vandenberg Village. Concrete repairs were also made by replacing 802.5 linear feet of curb and gutter, 211 square yards of cross gutter and spandrel, 431 square yards of driveways, and installing 22 new curb ramps that are compliant with the Americans with Disabilities Act (ADA).

The Director of Public Works, Scott McGolpin, accepted this project as complete on October 23, 2009. The project was completed on time and on budget.
