**AMENDMENT NO. 1 TO THE  
AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR WITH BOB'S BACKHOE &  
TRUCKING (trucking services)  
(BC NO. 18-169)**

Pursuant to Paragraph 30 of the Agreement for Services of Independent Contractor (hereinafter AGREEMENT) entered into on February 13, 2018 as **BC No.18-169**, between the Santa Barbara County Flood Control and Water Conservation District (hereafter COUNTY), and **Bob's Backhoe & Trucking**, having its principal place of business at 5775 Thornwood Drive, Goleta, California 93117 (hereafter CONTRACTOR), the COUNTY and CONTRACTOR amend the AGREEMENT as follows:

**1. Exhibit B, paragraph A is hereby amended to read:**

- A. For CONTRACTOR services to be rendered under this Agreement, CONTRACTOR shall be paid a total contract amount, including cost reimbursements, not to exceed **\$1,000,000**.

In all other respects, the AGREEMENT remains unchanged and in full effect.
