## RECOMMENDATIONS

That the Board of Supervisors adopt a resolution establishing a 20-Minute Parking Zone between the hours of 7:00a.m. to 6:30p.m. on Numancia Street in the Santa Ynez area.

## ALIGNMENT WITH BOARD STRATEGIC PLAN

The recommendation is primarily aligned with Goal #2: Ensure the public health and safety and provide essential infrastructure.

## EXECUTIVE SUMMARY & DISCUSSION

Numancia Street is a minor-collector road, which is a fairly low-volume local road, running east and west in Santa Ynez with fronting businesses on the north side of the roadway and open fields on the south side of the roadway. The roadway consists of two travel lanes with on-street parking in front of the businesses. A request was received from the business owners located on this section of roadway to paint green curb and establish a 20 minute parking zone between the hours of 7:00a.m. to 6:30p.m. All of the business owners support this action based on a field investigation, it was determined by the Public Works Traffic Section that due to the high demand for all day parking in the area, customers cannot access the businesses. The Public Works Department has determined that a 20 minute parking zone would be appropriate at the following location:

- On the north side of Numancia Street from a point 185 feet east of the centerline of Edison Street to a point 284 feet east of Edison Street.
