The County is pursuing the installation of solar photovoltaics systems via a Power Purchase Agreement at the Santa Maria Animal Shelter, located at 548 W. Foster Road, Santa Maria, CA 93455 (APN 111-231-004).

Determine that the renewable energy project is statutorily exempt from the provisions of CEQA pursuant to California Public Resources Code Section 21080.35 (installing solar systems on existing roofs and existing parking lots), and it is further categorically exempt from the provisions of CEQA per sections 15301 (minor alterations to existing facilities) and 15303 (limited construction of small facilities) and 15304 (minor alterations of land) of Title 14 of the California Code of Regulations and a Notice of Exemption was filed on that basis, and that the recommended actions are within the scope of that Notice of Exemption.
