Title: Increase Capital Asset Appropriations for Buena Vista Debris Basin Easement Acquisition

Budget Action: Increase appropriations of \$450,000 in Public Works South Coast Flood Zone Fund for Capital Assets funded by the release of Restricted Purpose of Fund balance.

Justification:

This budget revision increases FY2023-24 appropriations for the Buena Vista Debris Basin Project by \$450,000 in the Public Works South Coast Flood Zone to allocate additional project funding for two easement acquisitions. The final easement acquisition costs came in higher than expected, and additional funding is needed to cover the total costs of the acquisitions and project management costs.

A portion of the easement acquisition costs are included in the project's capital asset budget on page D-331 in the FY 2023-24 budget book under the Water Resources Division of the Public Works Department. The acquisition costs will be funded through The South Coast Flood Zone is funding the majority of the acquisition costs of \$1,222,000 and the remaining \$240,000 will be funded by the project's FEMA Hazard Mitigation Grant Program (HMGP). The HMGP grant previously funded \$234,883.50 for the project's design phase. The Flood Control District is actively working on submitting a phase two HMGP application, which will be used to fund construction costs for this project.
