## **Recommended Actions:**

That the Board of Supervisors:

- a) Certify that the Board has reviewed and considered the information contained in the Final Mitigated Negative Declaration (20NGD-00000-00012) and make the California Environmental Quality Act (CEQA) Findings required to adopt the Final Mitigated Negative Declaration (20NGD-00000-00012); and
- b) Approve the Project, adopt the Final Mitigated Negative Declaration (20NGD-00000-00012) and adopt the Mitigation Monitoring Plan included in the Final Mitigated Negative Declaration (20NGD-00000-00012); and
- c) Authorize the Director of Public Works to advertise for bids to construct East Mountain Drive Bridge No. 51C-0398 over Cold Spring Creek; Federal Project BRLO-5951(526); County Project No. 862357; First Supervisorial District.
- d) Approve the Budget Revision Request (BJE No. 0008031) to establish appropriations of \$351,000 in Public Works Roads Capital Infrastructure Fund for East Mountain Drive Low Water Crossing Replacement funded by revenues from the Federal Highway Bridge Program and Toll Credits.

#### **Summary Text:**

This item is on the agenda to adopt the Final Mitigated Negative Declaration 20NGD-00000-00012 (MND) and the Mitigation Monitoring Plan, and to authorize the Director of Public Works to advertise the project for construction bids.

The proposed project is located on East Mountain Drive and crosses over Cold Spring Creek, approximately 1.1 miles north of the State Route 192, and approximately 3.5 east of downtown City of Santa Barbara. The project will replace the previous low water crossing with a permanent bridge. The bridge will be approximately 70 feet long by 31 feet wide, pre-cast concrete structure and will clear span Cold Spring Creek. The bridge will accommodate two 12-foot lanes and a three-foot shoulder along the north side of the bridge. The shoulder will safely accommodate the passage of pedestrians accessing and exiting the trailhead and to provide room for bicyclists on the low volume rural road. All temporary and permanent project impacts will be outside the ordinary high-water mark.

Prior to the Thomas Fire Debris Flow Incident (TFDFI), East Mountain Drive crossed Cold Spring Creek via a low water crossing. The low water crossing consisted of a concrete slab poured over the bottom of the creek.

The TFDFI denuded of vegetation and completely reshaped Cold Spring Creek. The remaining pieces of the low water crossing consisted of concrete and exposed rebar, which were removed as part of the emergency repairs and clean up.

In June 2020 a temporary one-lane steel bridge was installed which allows for one-way traffic and emergency response with the use of stop signs.

The new bridge will incorporate architectural treatments such as bridge rail design with cobble-stone or sand-stone form liners and concrete staining. Additionally, form liners will be used on the abutments, wingwall and retaining walls.

As part of the design process, the Public Works Department prepared the MND to evaluate the environmental effects of constructing East Mountain Drive Bridge 51C-0398 over Cold Spring Creek.

Upon approval of the environmental document and authority to advertise, and following any necessary acquisition of right-of-way, the Department will proceed with advertisement of the project for construction bids.

Construction is scheduled to start in early summer of 2022 and finish in the summer of 2023. Public Works will publish the "Notice to Bidders" prior to the bid opening date. Sealed proposals are received electronically via the online portal at PlanetBids.com, at a date to be determined, and results will be posted immediately at the bid opening time.

#### **Background:**

The East Mountain Drive Bridge 51C-0398 is eligible for replacement under the Federal Highway Administration's Highway Bridge Program and will be replaced in cooperation with the California Department of Transportation (Caltrans).

Pursuant to CEQA requirements, the Public Works Department, acting as the lead agency, prepared the MND to evaluate potential environmental impacts of the proposed bridge replacement project. Potentially significant impacts in the areas of Biological Resources, Cultural Resources, Water Resources/Flooding, Noise, Fire Protection, and Public Facilities will be reduced to levels of less than significance through the Department's implementation of a Storm Water Pollution Prevention Plan, Habitat Restoration Plan, and other mitigation measures included in the MND.

On July 22, 2021, the Draft MND was released for a 30-day public comment period. The public comment period concluded on August 20, 2021, with no public comments received.
