Recommended Actions:

That the Board of Supervisors (Board):

- A. Approve and authorize the Chair to execute a "Second Amendment to Subrecipient Agreement" with United Way of Santa Barbara County to add funding in the amount of \$9,966,361.68 from the third tranche of the County's American Rescue Plan Emergency Rent Assistance (ERA 2) allocation for continued administration of an emergency rent assistance payment program (Attachment A); and
- B. Determine that the recommended actions are not the acceptance and approval of a project that is subject to environmental review under the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15378(b)(4), finding that the project is a creation of government funding mechanisms or other government fiscal activities, which do not involve any commitment to any specific project which may result in a potentially significant physical impact on the environment.

Summary Text:

Staff is recommending that the Board approve a Second Amendment to the Subrecipient Agreement with United Way (Attachment A). The Amendment makes certain changes to the Subrecipient Agreement approved by the Board on August 17, 2021. These changes increase the funding amount by \$9,966,361.68 comprising the third tranche of the County's American Rescue Plan Emergency Rent Assistance (ERA 2) direct Treasury allocation received since the First Amendment was ratified by the Board on October 19, 2021.

Background:

The President signed the American Rescue Plan Act of 2021 on March 11, 2021, which included \$21.55 billion in emergency rental assistance. Tribal communities, U.S. territories, states (including the District of Columbia), and local governments with populations over 200,000 are eligible to receive funding. With approval of the Second Amendment (Attachment A) recommended by this board letter, the County will have obligated its full U.S. Treasury allocation of \$16,610,602 in ERA 2 funds to United Way for administration of the local emergency rental assistance program. However, County staff will request additional U.S. Treasury funds to be reallocated to the County from other states that have underspent their emergency rental assistance funds distributed by the 2021 Appropriations Act (ERA 1). Additionally, on November 9th the Board authorized the Community Services Department Director to execute a subrecipient agreement with the State to receive up to \$30,000,000 of additional ERA 2 funds. Staff will return to the Board to obligate these additional emergency rental assistance funds once received.

Grantees can use up to 15% of their allocation for administrative costs attributable to providing financial assistance, housing stability services, and other affordable rental housing and eviction prevention activities. The Second Amendment provides for 10% of the allocation to be used for administrative expenses by United Way and their subcontractor Family Services Agency, and the remaining funds must be used for rent, rental arrears, utilities, utility arrears, and other housing expenses resulting from the pandemic for qualifying households. Updates to the U.S. Treasury program regulations include the eligibility of ERA funds to be used for prospective relocation assistance, including after an eviction.

United Way administered the County's prior 'ERA 1" allocation under the 2021 Consolidated Appropriations Act. On February 9, 2021 the Board of Supervisors approved a subrecipient agreement with United Way of Santa Barbara County to administer the County's direct \$13,275,190 allocation of 2021 Appropriations Act Emergency Rental Assistance (ERA 1) funding from U.S. Treasury. United Way's ERA 1 program assisted 1,413 households at or below 80% Area Median Income (AMI) with an average of \$8,262.25 in rent assistance. The vast majority of households assisted were families at or below 50% AMI. Of the \$6,644,240.84 ERA Round 2 funds previously contracted to United Way, approximately \$2,900,000 in direct assistance as been expended for 290 Santa Barbara County renter-households, approximately 4,500 applications have been received since the application portal opened on September 27, 2021.

The below table summarizes the status of ERA 1 and ERA 2 rounds for the County discussed above, and the State of California. The State is coordinating with the County to administer \$14,287,321 of ERA 1 to Santa Barbara County residents; \$7,900,000 in direct assistance has been expended for 875 Santa

Barbara County renter-households, and approximately 2,193 State applications have been received and are continuing to be processed. The State's application closed to new applicants on September 27, 2021. The State Block Grant Agreement for the ERA 2 funds is anticipated shortly and will be brought back to the Board for approval.

Performance Measure:

United Way/Family Services Agency will income-qualify persons served and document that County residents served have household incomes at or below 80% of the area median income (AMI), as determined and published by HUD annually. Residents with incomes at or below 50% AMI will be prioritized. United Way will report on the number of persons or households served on a monthly basis and must retain documentation for 5-years following the close-out of the program to indicate that the program was operated in accordance with the Treasury's Regulations.

Fiscal and Facilities Impacts:

County general funds have been budgeted and are used for a portion of HCD's overall administrative expenses; however, no County funds are being used to fund the Program.

Key Contract Risks:
