Title: Behavioral Wellness: Psynergy Contract Amendment FY 21-22

Budget Action: Increase appropriations of \$1,350,000 in Behavioral Wellness Mental Health Services Act Fund for Services and Supplies funded by unanticipated MHSA revenue from the State of \$1,163,700 and Medi-Cal Charges for Services of \$186,300.

Justification: The Department of Behavioral Wellness provides a continuum of mental health and substance use disorder services to Santa Barbara County residents, in part through contracted providers including Community-Based Organizations (CBOs). Contracts with facilities providing services at various levels of care are key to ensuring that the needs of clients are optimally met. Due to an increased demand for contracted long-term beds, Behavioral Wellness needs to amend Psynergy BC. This amendment will be funded by unanticipated MHSA revenue and Medi-Cal Charges for Services revenue from the State. Approval of this budget revision will allow Behavioral Wellness to continue to provide mandated mental health, substance use, and ancillary services.
