### OVERVIEW OF DJJ REALIGNMENT

- July 1, 2021, Department of Juvenile Justice no longer accepting youth from counties
- Realigns the responsibility of care, custody and supervision of realigned youth to counties
- Establishes the age of jurisdiction at age 23 or 25 for youth adjudicated of certain serious and/or violent offenses; age of jurisdiction for all other youth at 21
- Establishes a subcommittee of the local juvenile justice coordinating council within each county charged with developing the county's realignment plan
- Juvenile Justice Realignment Subcommittee of the JJCC is statutorily required to develop a separate plan
- Plan to describe facilities, programs, services, supervision and reentry strategies needed to provide appropriate rehabilitation and supervision services for youth



# 8 GUIDING PRINCIPLES<sup>1</sup>

- 1. Lead with values that promote equity and well-being
- 2. Maintain an uplifting and safe environment
- 3. Develop staff to build positive and supportive relationships
- 4. Provide varied, useful, and evidence based programming
- 5. Ground practice and culture in knowledge of adolescent development
- 6. Treat family members as partners
- 7. Encourage community connections
- 8. Incorporate continuous quality control
