- A.) Approve and accept the Notice of Completion for work performed by the Contractor, Granite Construction Company, Inc. (a local vendor), Post Office Box 6744, Santa Barbara, California 93160, and authorize Clerk to Record.
- B.) Approve and authorize the Chair to execute the Statement of Final Quantities for work performed and materials supplied for this project by the Contractor, in the amount of \$551,637.72.

Summary Text:

The construction of this project resurfaced 3.3 lane miles in the unincorporated areas of Goleta and Santa Maria (see attachment C for street locations). The scope of this project included repairs to failed pavement areas, placing Type-B asphalt concrete overlay on top of a Geosynthetic Pavement Interlayer, and an asphalt concrete leveling course.

The Director of Public Works accepted this project as complete on March 30, 2010. The project was completed on time and on budget.

Background:

To date, this project was one of eight that received federal 2009 ARRA stimulus funding. Of these ARRA projects, this is the second of two Asphalt Overlay projects. Designed to preserve and increase the longevity of several roads throughout the County, these projects involved roadway repairs and placing asphalt concrete overlays on the roadway. This project was located in the unincorporated area of Goleta, on Modoc Road, between State Street and Via Laguna Drive, and on Betteravia Road, from Hwy. 101 to 1 mile east of the Santa Maria City limits. On June 2, 2009, the Board approved and authorized the Director of Public Works to advertise for the construction bids, and approve the CEQA Notice of Exemptions and road rehabilitation locations. This project received authorization to proceed with construction from Caltrans on September 9, 2009.
