That the Board of Supervisors:

- A. Authorize the Chief Probation Officer to accept the 2011 California Office of Traffic Safety (OTS) Grant in the amount of \$97,550 for the period covering October 1, 2010 to September 30, 2011.
- B. Adopt the attached Budget Revision recognizing the unanticipated revenue.

<u>Summary Text:</u> Utilizing OTS grant funds the Santa Barbara County Probation Department will improve overall safety in the County through a combination of enforcement and supervision efforts. Enforcement activities will include locating driving under the influence (DUI) convicted absconders, and conducting surveillance and apprehension of unlicensed DUI probationers who drive. Supervision efforts will include targeting the highest risk DUI probationers in the Santa Maria region for increased field and office contacts, DUI program verification activities, searches, and alcohol testing.

Background:

On January 26, 2010, your Board authorized the Chief Probation Officer to submit an application for the 2011 California OTS Grant in the amount of \$198,950 for the period covering October 1, 2010 to September 30, 2012. The Probation Department has been notified that the application was successful and the project has been funded for one year in the amount \$97,550.

In line with the Department's current transition to Evidence Based Supervision, the application focused on providing risk and needs assessment specific to the DUI population and supervising the highest risk DUI offenders in the Santa Maria region on a dedicated DUI caseload. The officer assigned to this caseload will provide intensive supervision to these cases as well as working closely with the DUI treatment providers and assisting with the Secure Continuous Remote Alcohol Monitoring (SCRAM) program. The Santa Maria region was selected for this pilot effort, as it has the highest number of supervised DUI probationers, as well as the highest number of DUI offenders on the SCRAM program. The need to target this region is further demonstrated by OTS rankings data taken from the latest published California Highway Patrol (CHP) Statewide Integrated Traffic Records System (SWITRS) report, which included Santa Maria in a comparison of 103 like-sized California cities and revealed that Santa Maria ranked the second highest in the number of alcohol-involved collisions that resulted in killed and injured victims.

Probation Department: Increase appropriations to recognize \$73,163 of revenue to fund a Deputy Probation Officer, supplies and travel expenses required by the Office of Traffic Safety (OTS) grant for Fiscal Year 2010-11. The total OTS grant award for Federal Fiscal Year 2010-11 is \$97,550. The remaining amount of \$24,387 of the Federal Fiscal Year 2010-11 grant award will be included in Fiscal Year 2011-12 budget.

This budget revision increases revenues by \$73,163 of the total \$97,550 Federal Fiscal Year 2010-11 Office of Traffic Safety (OTS) grant award in line item account 4789 "Federal-Other" to recognize unanticipated revenues to fund a Deputy Probation Officer to improve overall safety in County through a combination of enforcement and supervision efforts. Appropriations will be increased in 'Salaries and Benefits" by \$71,732, in line item account 7650 ""Special Departmental Expense" by \$531 and in line item account 7730 "Transportation and Travel" by \$900. The remaining amount of \$24,387 of the \$97,550 OTS Federal Fiscal Year 2010-11 grant award will be included in Fiscal Year 2011-12 budget.
